Climbers for Christ prioritizes the privacy and protection of its members and partners. This Privacy Policy describes how Climbers for Christ collects, uses, and discloses your personal information when you visit, use our services, donate or make a purchase from [climbersforchrist.org](http://climbersforchrist.org) or otherwise communicate with us.

### **How We Collect and Use Your Personal Information**

To provide you with resources and information on Climbers for Christ, we collect information about you through interest forms, membership sign-ups, donation forms, and through event ticketing in order to process your donation, membership, event ticketing, or to request more info. We only share your information if explicitly requested to do so for donation processing, or to connect you to local events, chapters, and partners. Climbers for Christ will not sell or give your information to anyone outside of the organization.

### **Information We Collect Directly from You**

Information that you directly submit to us may include:

- Basic contact details including your name, address, phone number, email, date of birth, and payment information.
- Personal interests you may include when you fill out our interest form.
- Donor support information including the information you choose to include in communications with us, for example, when sending a message to our membership support team.

### **Information We Obtain from Third Parties**

We may obtain information about you from third parties, including from vendors and service providers who may collect information on our behalf, such as our customer relationship management platform, member platform, merch fulfillment service, and payment processor to process donation or membership information.

Any information we obtain from third parties will be treated in accordance with this Privacy Policy. We are not responsible or liable for the accuracy of the information provided to us by third parties and are not responsible for any third party's policies or practices.
